1 *Be it enacted by the Legislature of the Virgin Islands:*

2       **SECTION 1.** The following sums, or so much thereof as may be necessary, are  
3 appropriated from the General Fund of the Treasury of the Government of the Virgin Islands  
4 for the operating expenses, including maintenance, supplies and equipment, and other purposes  
5 of the Virgin Islands Government Hospitals and Health Facilities Corporation for the fiscal  
6 year October 1, 2024 through September 30, 2025.

6 Schneider Regional Medical Center and \$31,250,000 is appropriated to the Governor Juan F.  
7 Luis Hospital and Medical Center for the fiscal year ending September 30, 2025.
