1 *Be it enacted by the Legislature of the Virgin Islands:*

2 **SECTION 1.** (a) The sum of \$2,512,000 is appropriated in the fiscal year ending
3 September 30, 2025, from the St. Croix Capital Improvement Fund to the Department of Public
4 Works for road repairs in the following:
