1 *Be it enacted by the Legislature of the Virgin Islands:*

2       **SECTION 1.** (a) The sum of \$2,170,000 is appropriated in the fiscal year ending  
3 September 30, 2025 from the St. Thomas Capital Improvement Fund to the Department of  
4 Public Works for the following road repair and maintenance projects:
