An Act appropriating \$11,000,000 from the Transportation Trust Fund as a contribution to the General Fund of the Treasury of the Government of the Virgin Islands for operating expenses for the V.I. Bureau of Motor Vehicles and the Department of Public Works in the fiscal year October 1, 2024 through September 30, 2025

*Be it enacted by the legislature of the Virgin Islands:*

**SECTION 1.** Notwithstanding 33 Virgin Islands Code, section 3003a, \$11,000,000 is appropriated from the Transportation Trust Fund as a contribution to the General Fund in the fiscal year October 1, 2024 through September 30, 2025.

**SECTION 2.** The following sum, or so much thereof as may be necessary, is appropriated from the amount transferred in Section 1 to the Virgin Islands Bureau of Motor Vehicles and the Department of Public Works for operating expenses, including wages of salaried employees of the Virgin Islands Bureau of Motor Vehicles and the Department of Public Works for the fiscal year October 1, 2024, through September 30, 2025.
