1 *Be it enacted by the legislature of the Virgin Islands:*

2 **SECTION 1.** The following sum or so much thereof as may be necessary, is
3 appropriated from the Sewer Waste Water Fund for operating expenses including maintenance,
4 supplies, machinery and equipment and other purposes of the Waste Management Authority
5 for the Fiscal Year October 1, 2024 to September 30, 2025.
